To Vote by Proxy

If you wish to vote by proxy, you must complete this section and give this page (both front and back) to the person who will be attending the meeting to vote on your behalf. **ONLY THIS PROXY FORM (which is also available on the FORHA website for your convenience) WILL BE ACCEPTED.** If you choose to designate a proxy and your proxy does not attend the meeting, no vote will be cast for you.

THE PROXY

The undersigned, a member of the Fair Oaks Ranch Homeowners' Association acting on behalf of all of the owners of the property described below does hereby appoint _____ (or if no individual is designated, then the Secretary of the Association) as my proxy ("Proxy Holder"), and, if so indicated below, to vote as directed in my place and stead on my behalf as though I myself were present, with the power of substitution, at the 2022 Annual Meeting of Members on November 29, 2022, or any adjournment or continuation thereof with the same effect as if the undersigned were present and voting on any business to be conducted at the 2022 Meeting of Members.

QUORUM ONLY: Assign this proxy to the Secretary of the Association with the stipulation to **abstain** from casting my vote(s) and to use my proxy for the purpose of **establishing a quorum only at the 2022 Annual Meeting of Members to be held on November 29, 2022.**

DESIGNATED REPRESENTATIVE, General Proxy: I authorize my Proxy Holder to **vote on my behalf and to represent me** on all matters as though I were personally attending the 2022 Annual Meeting of Members to be held on November 29, 2022. *"Designated Representative will be given a ballot at the meeting to be completed for the purposes of voting."* A ballot must be attached to this proxy for the vote of the designated representative to be valid.

DIRECTED PROXY: I authorize my Proxy Holder to cast **votes on my behalf at the 2022 Annual Meeting of Members to be held on November 29, 2022, in the manner that I have indicated on the following page.**

This proxy is revocable at any time before it is exercised. If you cast a ballot after you sign this proxy, the ballot will supersede the proxy. You also have the right to attend the Annual Meeting and vote in person. **(You must sign, date, print name and include your property address below for this proxy to be valid.**)
